

SUMMARY ANNUAL REPORT

Joseph Holt Plastering, Inc. 401k Profit Sharing Plan

This is a summary of the annual report for Joseph Holt Plastering, Inc. 401k Profit Sharing Plan, 20-2533580/001 for 01/01/2023 through 12/31/2023. The annual report has been filed with the Employee Benefits Security Administration, formerly known as the Pension and Welfare Benefits Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Basic Financial Statement

Benefits under the plan are provided by insurance and trust. Plan expenses were \$135,047. These expenses included \$10,697 in administrative expenses and \$124,350 in benefits paid to participants and beneficiaries, and \$0 in other expenses. A total of 323 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, was \$1,560,218 as of 12/31/2023, compared to \$1,327,874 as of 01/01/2023. During the plan year the plan experienced an increase in its net assets of \$232,344. This increase includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$367,391, including employer contributions of \$60,910, employee contributions of \$120,104, gains of \$0 from the sale of assets and earnings from investments of \$186,377.

The charge to cover copying costs given above does not include a charge for copying of these portions of the report because these portions are furnished without charge.
